### RATIONALE AND PURPOSE OF THE QUALIFICATION

### **RATIONALE**

Public Sector project management can lead to a fulfilling career in the public sector or private sector. Knowing how to successfully manage a project from start to finish can be the difference between success and failure. It is an increasingly in-demand skill and studying it can boost a career in any industry by building skills capacity required to improve or elevate a country's ability to achieve national goals.

In Botswana, these national goals include poverty reduction and making life better for citizens (Vision 2036; NDP 11). Attaining national goal priorities requires converting those intent into projects. This postgraduate qualification is designed to address the particular and daunting challenges of managing public sector projects and increasing project management skills in the public sector. A Needs Assessment survey conducted in 2019 shows that advanced skills such as project management methods and project evaluation and scoping in public sector project management are required in the economy and addresses the HRDC-identified gaps in skills, where the country has produced a lot of skilled/qualified citizens at undergraduate level with few postgraduates.

The skills sector analysis report of 2016/17 published by the Human Resource Development Council (HRDC) further highlight the need for Project management in the local market. The report lists project management as one of the key top areas that require training and skills upgrade to minimize corporate scandals, improve productivity and optimize success of organizations in the country (HRDC, 2016/17). This qualification therefore develops the requisite skills, knowledge and competencies among practitioners for effective project management practices in enterprises. The broader significance of improved project management is that, more emphasis on efficiency associated with project management is highly enforced; Botswana stands a better chance to achieve its vision of greater accountability.

According to the NDP 11 (April 2017-March 2023) the development of the Education and Training Sector Strategic Plan (ETSSP 2015-2020) was completed in May 2015. Its objective amongst others was to reform the education system and address issues of poor performance in the sector. The implementation of some of its programmes and initiatives started during NDP 10 and these included among others the development of a Technical and Vocational Education and Training (TVET) Policy Framework for revitalisation of the TVET subsector. A National Curriculum and Assessment Framework (NCAF) for general education was also developed to improve the quality and relevance of education at this level by adopting an outcome-based education

A needs assessment survey was conducted in 2019, whose objective was to investigate the demand and attractiveness of qualifications to be offered by the ETP. The survey targeted current and prospective students as well as public and private sectors. The findings from the survey revealed that project management skills were highly sought. The findings for the Postgraduate Diploma in Public Sector Project Management and others are derived from a questionnaire that was distributed to various organizations across multiple industrial sectors. 50 questionnaires were administered and 34 were successfully completed giving a response rate of 68%. Analysis of the data was done using Jupyter Notebook and SPPS. The questionnaire sought to get feedback on the relevance, need and desirable graduate skills for the Postgraduate Diploma in Public Sector Project Management qualification. About 85.2 % of the respondents indicated that the qualification is relevant to the human resources needs in Botswana.

The qualification introduces project management methods and tools that have proven useful in both the public and private sector enterprises, and it identifies the challenges in the public sector project management area as

well as the international best practices for dealing with these challenges. This dimension of the qualification of developing learners to problem solvers by identifying project management challenges and solutions makes the qualification uniquely relevant and timely for the Botswana context since the public sector projects continue to face diverse challenges for which there seem to be no immediate solutions.

By making the qualification for public sector project managers, it allows these managers as well as emerging ones who want to optimize project outcomes and make a positive contribution to their agencies and organizations, to gain the requisite skills and be fully equipped to do so. The public sector project management landscape at the moment face issues, for instance with meeting project deadlines, and managing contracts that are formed with private sector suppliers (PPADB, 2016). The qualification addresses these issues. It is for those who have worried about meeting a deadline for a project or getting the support of their stakeholders. It is also for those private-sector project personnel who are managing projects under contract with the public sector so that they fully appreciate the challenges that go with this activity. Given this kind of focus, the qualification is most vital and valued in building relevant competency for growth and national development because contemporary project management practices, principles, theories, and concepts are required to form the basis for professional judgment in decision making on issues faced in modern public sector project management. Likewise, as evidence indicate, research-informed professional practice is required to manage, lead and deliver life-enhancing and value-adding public sector project management (CIPFA June 2013, Good Governance in the Public Sector- consultation Draft for an International Framework)

Beyond the practitioner related justification, there are also academic related significance to offer the qualification. The higher education system in the country currently is predominantly an undergraduate focused system. Few opportunities are available in the system for vertical progression in one's field of study and the area of project management is one such area. Therefore, the qualification serves to expand education access beyond the bachelor's degree; in this regard, it is a tactic to support articulation into other qualifications.

# **PURPOSE**

The aims of the qualification are to provide the learner with first-hand knowledge across all public sector business functions through a mixture of creative and organizational tasks in managing of projects, and to place the field of public sector project management into perspective and details what the learner need and should know to succeed within it. More specifically, the qualification is an attempt to, among others:

- Develop a grounded appreciation of contemporary/ current theories, principles, concepts and practices of public sector project management.
- Critically analyze, independently review and evaluate specialized knowledge of public sector project management so as to be able to make expert recommendations on alternative courses of action that add value to stakeholders.
- Demonstrate mastery of the practice of public sector project management as an emerging profession and carry out basic research using the concepts, models and ideas of best practice in the field in a creative manner that synthesizes current knowledge and practice; and,
- Enhance learner ability to evaluate essential aspects of public sector management.
- Enhance learner ability to evaluate and use knowledge management in project management
- Enhance learner ability to use business management and strategic tools in project management

### **ASSESSMENT AND MODERATION ARRANGEMENTS**

### **ASSESSMENT ARRANGEMENTS**

Assessment shall take two forms that is formative and summative as indicated below:

- a. **Formative assessment** shall be employed to provide students with feedback on their achievements, and to provide guidance to students on how to improve their performance. Formative assessment shall serve to support students in the learning process, and to inform module/programme development.
- b. Continuous assessment shall be designed to consider all aspects of a student's performance at various stages of the learning process. The contribution of formative assessment to the final grade shall be **40%**.
- c. Summative assessment The contribution of Summative assessment shall be 60%.

#### **MODERATION ARRANGEMENTS**

Internal and external moderators to be engaged will be BQA accredited subject specialists in relevant fields with relevant industry experience and academic qualifications.

# QUALIFICATION AWARD AND CERTIFICATION

A **Postgraduate Diploma in Public Sector Project Management** will be awarded to a Candidate upon completion of the qualification in accordance with applicable policies. A certificate and transcript will be issued at award.

## **Similarities**

Modules offered by all institutions are similar and learning outcomes are similar.

Entry requirements are basically the same at bachelor's degree NCQF level 7. Awards are similar at NCQF level 8.

#### **Differences**

The ETP award a Postgraduate Diploma in Public Sector Project Management while MANCOSA and University of Stellenbosch offer Postgraduate Diploma in Project Management and Vancouver Island University offer Graduate Diploma in Project Management.

Vancouver Island University offers 9 modules for the qualification while the rest of the institutions offer 8 modules for the qualification.

The qualification shall be reviewed on a 5-year cycle.
