#### RATIONALE AND PURPOSE OF THE QUALIFICATION

The discipline of Political Science is concerned with the exercise of political power, both at the state and the international level. Political Science has a number of sub-disciplines, such as International Relations, International Political Economy, Security Studies, Political Theory, Public Policy, and Comparative Politics. Since Political Science is concerned with the use of political power, graduates of Political Science have a better understanding of how the world works, and how it could be improved. Political Science qualification is relevant for Botswana's economy because as the country strives towards a knowledge-based economy and the 4<sup>th</sup> Industrial revolution, it is imperative to produce graduates who are skilled in governance and leadership and competent to devise evidence-based policies that address emerging challenges. This is consistent with one of Botswana's vision 2036 aspirations of a knowledge-based economy which is the first pillar of vision 2036. More precisely, to achieve a knowledge-based economy, the country aspires to develop its education, training and skills development systems that embrace science, innovation and technology. Related, the pillar recognizes the importance of human capital in driving economic growth across all the sectors. More specifically, pillar 4 of the vision speaks to governance, peace and security, which are the cornerstones of any functioning democracy. Amongst the objectives to be achieved under

this pillar, institutional framework, transparency and accountability, separation of powers and effective oversight as well as good foreign relations. On this basis, Political Science qualification is ever relevant to meet Botswana's economic demands. The qualification is tailor-made to produce graduates that are prepared to drive the objectives of Vision 2036 particularly pillars one and four.

Over the years, graduates of Political Science have worked in various state institutions, the private sector, and some international organizations. However, as the country attempts to transform from a resource-driven to a knowledge-based economy, particularly in line with Vision 2036, there is need for a new graduate who is not only equipped to work for the state institutions and international organizations, but also has a better understanding of how political power works, at both the state and the international level. Therefore, the rationale of this qualification is to produce a well-rounded graduate who has a better understanding of not only how power works, but also a full conception of the dynamic world, particularly its challenges and opportunities.

#### **PURPOSE:**

The purpose of this qualification is to produce graduates with specialized knowledge, advanced technical skills, and competences to:

- Formulate policy and resolution of day-to-day development challenges of their societies and the world at large.
- Understand specialized knowledge in the dynamics of power and authority and their practical application in government, non-governmental organizations, the private sector and international organization.
- Lead and govern in any organization.
- Apply public relations, marketing, conflict resolution and management, diplomatic negotiations, political analysis, and research.

## 12.0 REGIONAL AND INTERNATIONAL COMPARABILITY

The qualification was benchmarked with regional and international universities namely University of Namibia in SADC region and University of Leicester in UK. The qualification compares well with the BA in Political Science qualification offered at the University of Namibia and Bachelor of Arts in Politics offered by the University of Leicester in the United Kingdom. As illustrated below, the title of the qualification, the level, credit value and main exit outcome closely match the BA Political Science qualification.

# **Comparability with regional University**

The University of Namibia was used in the SADC region to compare its Bachelor of Arts in Political Studies with the Bachelor of Arts in Political Science. The following is a summary of similarities and differences between the qualifications:

#### <u>Similarities</u>

- Both qualifications have similar entry requirements
- Both qualifications take a duration of 4 years to complete
- The qualifications generally follow the same structure in terms of courses studied across academic years and semesters with slight differences in terminology.
- The qualifications offered at UNAM and UB have similar progression pathways for graduates.

# **Differences**

- Though similar in some respects, the number of credits for the BA Political Science qualification at University of Namibia is higher compared to the UB qualification.
- The weekly contact hours for BA Political Science in University of Namibia are more than the weekly contact hours for the UB qualification.
- The assessment criteria for the qualifications are different in terms of the weightings and assessment activities. While assessment for BA Political Science courses in Namibia uses a ratio of 50:50, the UB qualification uses 60:40.

# **Comparability with an international University**

## **Similarities**

- The qualification also compares well with other international Universities such as University of Leicester in the United Kingdom, namely Bachelor of Arts in Politics. The student learning outcomes are similar and have very related objectives. For example, on the modules sampled above, "Botswana Politics" and "Political Participation in Britain", share common exit outcomes.
- The same goes for, the objectives of teaching "International Relations, Statecraft and Political Conflict in Africa" and "Contemporary Africa." For most courses taught at the University of Leicester, the

similarity rests on the learning outcomes.

 Both the University of Botswana and University of Leicester's BA qualifications carry a credit load of 480 credits, that is, 120 credits per academic year.

#### Differences

- The main difference lie on the contexts within with the courses / modules may discuss certain concepts. For example, comparative politics at the University of Leicester is limited to Europe. On the same wavelength, whilst the latter will teach "European Union Politics", the University of Botswana will teach "Politics of Southern Africa", yet the theme under both modules is regional politics.
- The University of Botswana offers four years of study, while the University of Leicester offer three years of study with an option to take one academic year at Level 300 with some other University. Whilst, in the main structure this is a different practice, the University of Botswana is also flexible with credits acquired from a competent University.
- Though similar in learning outcomes, the University of Leicester teaching and learning methods are
  much more rigorous as they include seminars, role playing and simulations while the University of
  Botswana programme methods are limited to lectures and tutorials.

#### **REVIEW PERIOD**

This Qualification will be reviewed after every 5 years.
